#### 12.5 GM-05-17-51 - Grand River Water Management Plan: 2016 Report on Actions

S. Cooke presented a summary of the 2016 Report on Actions. This is the third annual report which summarizes the status of 182 actions included in the Water Management Plan. The Plan is supported by federal and municipal governments, and Six Nations of the Grand River, and outlines the collaborative effort to improve water quality, ensure water supplies, reduce flood damages, and build resilience to deal with climate change. The report highlights actions taken over the past year, and the anticipated next steps for continuous improvement of the watershed.

#### 12.6 GM-05-17-59 - Beach Management in GRCA Conservation Areas

S. Cooke responded to Board members' questions, highlighting that the decision to stop water sampling at GRCA beaches was made by Public Health officials. Following their review, it was decided that from a public health perspective, water quality can change too quickly for the current method of testing to provide accurate water quality information to the public. S. Cooke explained that GRCA staff have started to analyze historic data in an effort to review water quality trends at GRCA parks. G. Lorentz commented that a measured approach should be taken, as public safety must be considered if we are to encourage the public to swim at our parks. C. White asked who is taking responsibility, and H. Jowett noted that staff are currently working with the three Public Health Units in the Grand River Watershed, and will continue to update the Board on this matter.

M. Salisbury said that it would be good see historical data on postings, information on risk analysis, and to take responsibility for sampling GRCA beaches. S. Cooke responded that the current method of 'posting' beaches is not to close a beach, but to communicate a measure of risk. J. Mitchell asked about

current practices to keep GRCA beaches clean, and S. Cooke responded that parks staff perform daily inspections. GRCA does not have the resources for daily water quality testing, as these types of tests must be completed in an accredited lab facility.

There was some further discussion regarding communicating the level of risk, and educating the public to self-assess water quality. Board members will be kept up to date on details and staff will prepare an additional report for the June board meeting.
