3. Chair's Remarks

The Chair welcomed the Members and made the following remarks:

Earlier this month our Chair, Foundation Members Malcolm Matheson and Joel Doherty, and several staff members attended a ceremony at Dumfries Park here in Cambridge. The event included unveiling a special rock engraved to recognize Percy Hilborn's contribution to the community by donating the land that has since become Dumfries Park. The property is a 75 hectare property in the center of Cambridge that provides the community with a natural space to enjoy and appreciate nature.

Bill 139 was introduced to legislature for the 2nd reading on Monday, September 11. Minister McGarry showed strong support for conservation authorities, and talked about GRCA specific program areas.

GRCA Chair and staff, and members of Lake Erie Source Protection Committee are scheduled to meet with Minister McGarry on November 3 to discuss source protection programs and planning.

Minister McGarry will also be in attendance at the Conservation Ontario Council meeting on September 25. H. Jowett and J. Farwell will attend the meeting.

- D. Boyd presented an overview of the Water Control Structures Capital Forecast. Annual dam and dyke inspections, repairs, public safety concerns, technical studies, safety reviews, and external consultants make up the majority of costs.
- D. Boyd responded to questions from board members, explaining the purpose of stop logs at dams, updated digital mapping for certain areas in the watershed, and tree and vegetation removal around dykes.
- K. McElwain noted that there was nothing outlined in the forecast for the West Montrose Dam. D. Boyd said that he is preparing a board report to provide an overview of the West Montrose Dam, adding that it is not an active project.

12.8 GM-09-17-100 - Current Watershed Conditions

D. Boyd presented the current watershed conditions. New information regarding the June 23rd flood event showed that the Harriston area received 170mm of rainfall during the event, and that tropical moisture from Hurricane Cindy may have contributed to the rainfall.

Current conditions are drier than in August, and higher than average temperatures are predicted throughout October. Temperatures will begin to drop closer to November and into the winter months.

- D. Neumann asked about the expectation for Lake Erie water levels. D. Boyd said that there could be a higher potential for lake surge events once air temperatures begin to cool off, also noting that it is too soon to tell if the lakes will freeze this winter.
- S. Foxton mentioned that she had recently attended an emergency services training session, where the mock emergency was a flood. S. Foxton noted that the role the GRCA plays during a flood event was not highlighted enough during the mock event.
