12.8 GM-10-17-106 - Seasonal Camping Update - 2017

D. Bennett provided a presentation to accompany this report, which included details of the current practice for seasonal camping and financial highlights regarding costs and revenue. A seasonal camping guide is currently being created to provide campers with a more concise outline of seasonal camping regulations.

In response to questions from board members, D. Bennett noted that both the occupancy rates of nightly sites, and the desirability of the sites, varies across the parks and that additions on seasonal sites must not be concrete or have a permanent foundation; decks and sheds must be removable. S. Simons asked if Pinehurst campers will be required to move their trailers for this upcoming winter, and D. Bennett confirmed that trailers in the Pinehurst sites will not move this

year. Staff do have requirements from the ESA, and staff are working towards removal of trailers at all seasonal sites, recognizing that it will take time to transition to this practice. Alternative options for winter storage are being reviewed. S. Simons requested that campers be kept informed of any changes to their current agreements.

G. Lorentz noted that the report does not seem to reflect actual policies. D. Bennett responded that the seasonal camping guide is being drafted in order to more clearly outline policies and procedures of seasonal camping at GRCA parks. A full report will be brought back to the board when the new guide is complete. G. Lorentz asked about wait lists for seasonal sites and the percentage of campers who do not renew their sites on an annual basis. D. Bennett said that turnover rates are low, and that they vary across the parks. G. Lorentz said that an element of fairness to all members of the public should be considered when reviewing the current policy. C. Lunau added that public campgrounds are intended to serve the public, and that a termination policy for seasonal camping should be in place.
