# 8. Hearing of Delegations

# 8.1 Concerned Residents Coalition

S. De Grandis spoke before the board regarding the key issues as seen by the Concerned Residents Coalition (CRC) in regard to the Hidden Quarry application, and to note concerns relating to the involvement of the GRCA on the review of the application. Board members received a Fast Facts sheet, which outlined the key issues of the CRC from the delegation.

D. Tripp provided a conclusion regarding an apparent lack of technical justifications for the recommendations of the GRCA, and expressed concern that third party reports are not reviewed by GRCA staff.

J. Mitchell joined the meeting at 9:45 a.m.

N. Davy thanked the delegation and provided a brief summary of the GRCA's involvement. Materials were reviewed and comments were provided to the applicant. The GRCA provided comments to the applicant and the municipality. The application is now before the OMB, and the process will include expert meetings. The GRCA has been asked to participate in the meetings to discuss all of the facts with other experts. GRCA staff are prepared to participate.

C. Lunau joined the meeting at 9:50 a.m.

In response to questions from board members, N. Davy noted the following:

- CRC will be included in the OMB expert meetings as a party to the appeal.
- The same legislation that amended the Conservation Authorities Act also amended the Ontario Municipal Board (OMB) Act. The OMB is now called the Local Planning Appeal Tribunal. The two names are being used interchangeably during the transition period.

B. Corbett commented that there is no lack of transparency from the GRCA, as a report provided comments to the municipal planning department. The GRCA is not required to provide comments to third parties.

# 12.2 GM-06-18-67 - Chief Administrative Officer's Report

J. Farwell provided an update from the CAO's report in regard to ongoing flooding concerns in New Hamburg. GRCA staff have identified an opportunity to apply for funding through the National Disaster Mitigation Program to help address the concerns. Further study will be required, and a report regarding funding options will be brought to the board in August.

B. Corbett asked about criterion for the federal program. D. Boyd responded that there are four main components to the program: risk assessment, hazard

mapping, mitigation options, and small projects. A cost benefit analysis of any mitigation project would be required for potential funding.

L. Armstrong commented that a lot of work has been done by the township, including updates to the flood warning system and repairs to the berm near downtown, and agrees that further study is required.

J. Mitchell asked if there is a possibility to partner with the new alert ready system. D. Boyd said that there is very specific criteria for emergency notifications through that system, and added that the GRCA is exploring opportunities with other agencies to make use of alternative alert systems.
