## 12.1 GM-03-19-28 - Unauthorized Tenting on GRCA Properties

- J.Farwell discussed homelessness and unauthorized tenting on GRCA properties, advising the board that GRCA staff have joined a harm reduction working group with the Region of Waterloo Public Health; a group committed to working with partners to find solutions for homelessness in the region. GRCA staff will also be installing two biohazardous material disposal units, one each on the Hespeler trail and Dumfries Conservation Area. J.Farwell reiterated that there is no single solution to this ongoing issue, and that the GRCA will continue to collaborate with partner agencies to help find appropriate solutions
- The Chair noted confidence with WRPS protocols and GRCA staff's proactive approach to the concerns, adding that the City (Cambridge) is responsible for trespassing bylaws and the Region (Waterloo) is responsible for the inventory of shelter beds

- D.Boyd provided a PowerPoint presentation of the current watershed conditions, highlighting Spring ice break-up, some flooding in several areas during late February and early March, and high Lake Erie levels and their cyclic nature
- B.Corbett asked if the increased levels of Lake Erie could be a result of climate change, and D.Boyd indicated that the trend of static levels are increasing and that part of the Haldimand County shoreline hazardous mapping project will look at climate change and how to handle the upward trend in planning for the future

 D.Boyd also provided an update on the jet fuel spill that occurred near Mill Creek in January. Remediation efforts are ongoing, and staff are receiving regular updates on the progress. Staff will continue to receive monitoring data and plan and adapt programs at Shade's Mills as necessary. Relevant information regarding programs and activities at Shade's will be communicated as needed

### 17.1 GM-03-19-C02 - Property Disposition - City of Guelph

The property at 180 Gordon Street in the City of Guelph is situated along one of the main thoroughfares in the City. The City of Guelph for a number of years has encouraged infill and brownfield development, where appropriate in the City. This particular site is small and narrow; however, developers have been able to design a low-rise residential building on the property. In order to meet the Ontario Building Code, a limiting distance requirement is necessary to protect adjacent properties and buildings from fire within the proposed condominium building, and vice-versa.

## 17.3 GM-03-19-C04 - Grant of Easement – Cambridge

The Region of Waterloo is constructing the South Boundary Road and Franklin Boulevard extension (Phase 1B). As part of the project there are some drainage works being completed and a multi-use trail being installed west of Water Street. The Region of Waterloo has requested two easements to accommodate this project; one easement is to install a connection to the rail trail owned by the GRCA and the other is to install a stormwater outlet on the GRCA's property.

It is proposed that once the plans have been finalized and approved, a survey will be completed to delineate the easement areas and a reference plan will be prepared to define the subject areas. It is proposed that the Region of Waterloo and the GRCA will enter into two separate easement agreements, one for the trail connection and one for the stormwater outlet infrastructure. Initially, the Region of Waterloo will enter into both easement agreements. Once the project is completed, the easement for the stormwater outlet is proposed to become the responsibility of the Ministry of Transportation.
