- The Grand River Conservation Foundation 2018 Annual Report has been published and copy has been provided to Members
- Recently OMAFRA and MRNF staff received an Amethyst Award for the LiDAR project they completed. Their project provided LiDAR mapping across our entire watershed and greatly reduced costs associated with updating floodplain mapping and removed barriers to moving to digital floodplain mapping. This represents a great milestone in LiDAR data acquisition and dissemination and acknowledges the value of this data for the public good
- Beth Brown has accepted the role of Manager of Property. Ms.Brown has been with the GRCA since 1998 in a number of positions, most recently as Supervisor of Resource Planning. Through her education and experience, Ms.Brown has developed and demonstrated key skills in project management, planning and regulatory enforcement, effective communication, conflict resolution, collaboration and leadership, all of which will serve her well in her new position

8. Hearing of Delegations

8.2 Clare Gingrich et al - West Montrose Ice Jam Concerns

The Board heard from a group of West Montrose residents regarding their collective concerns of possible ice jams in the Grand River near their homes. The concerns were raised due to a new gravel deposit that formed a small island downstream of the West Montrose covered bridge. Mr. and Mrs. Clare and Miriam Gingrich and Mr. Hans Pottkamper shared concerns of potential flooding and damage to the heritage bridge and asked that the Board consider options for removal of the gravel deposit to reduce the potential risks.

D.Boyd provided a brief presentation and responded to Board questions indicating that the GRCA is monitoring the area and completing assessments, and will initiate mitigation if deemed necessary by the outcome of the assessments. The GRCA understands the concerns of the residents and will make a determination on the need for intervention once the assessments are complete and an information report outlining the results will be brought to the Board at that time. D.Boyd added that ice jams are extremely hard to predict and that weather conditions will be monitored throughout the winter months.

The Board heard from Mr. Leonard Chaplinsky and Ms. Julia Morison who shared documentation regarding the property they currently lease from the GRCA and reiterated their interest in purchasing the property. The named property was further discussed with the staff report at agenda item 12.a.

12.1 GM-09-19-90 - Residential Program Wind-down - Demolitions

B.Brown provided a detailed overview of the report, highlighting the background of the Board approved Residential Wind-down Program and each of four options that was considered during the review of every residential home in the program. GRCA staff considered this property in the same manner as other homes in order to maintain a consistent and objective approach. Options for considerations include: retaining the property for GRCA use, selling the entire parcel, severing and selling the property, or a demolition of the house and retaining the property. B.Brown provided details of each consideration and reiterated the staff recommendation to demolish the home.

Board members discussed the current state of the home and the property's estimated value, the tenant's commercial business being operated on the property, potential future uses of the property, liabilities as the landlord of the property, other existing leases on the parcel, and relevant legislation and guidelines the GRCA must adhere to when considering the severance or sale of property.
