9.1 Grand River Watershed Water Quality

K.Davis joined the meeting at 9:40 a.m.

- D.Boyd provided a presentation on the history of water quality in the Grand River watershed, which highlighted changes in land use and conditions that affected the water quality dating back to the 1920s, the collaborative efforts of the watershed agency, municipalities and other partners, and the ongoing actions taken since then to address issues and improve the quality of the water in the Grand
- M.Anderson continued the presentation, and provided detailed information on the complex nature of water quality, changing conditions of the watershed and surrounding landscape, implementation of programs to improve sewage treatment plants and farming practices, reforestation efforts and wetland restoration, which have all contributed to major improvements in water quality. The Grand River supports a diverse ecosystem, many species-atrisk, as well as a variety of recreation with trail systems, paddling, and fishing
- M.Anderson noted that the key message from the presentation is that through collaboration with and investment by partners, there have been huge strides in improving the quality of water in the river
- Board members thanked staff for the presentation and discussed sharing the information provided with external parties to raise awareness and celebrate the strong efforts and hard work of conservation authorities

- B.Corbett requested an update on Lake Erie water levels. D.Boyd noted that an updated conditions statement will be issued through the media following the meeting. The water level remains high and is above the long term average. As the season changes to fall, there will be a higher risk of lake surges, erosion and flooding, and the public will be notified through the media release and regular advisory channels to prepare for the fall season
