#### 1. Call to Order

The Meeting was called to order by the Chair at 9:31 a.m.

# 2. Certification of Quorum

The Secretary-Treasurer called the roll and certified a quorum with more than half of the Members present. A total of 25 Members attended the meeting.

#### 3. Chair's Remarks

The Chair welcomed the Members, guests, and staff and thanked everyone for attending the Annual General Meeting. Guests were introduced and provided brief greetings. The Chair also welcomed some past members who have completed their terms with this Board. Outgoing Members were presented with a photo plaque in recognition of their service, and they are wished all the best in their future endeavours.

Following the recognition of service, the Chair made the following remarks:

- On February 22, the GRCA hosted the Flood Warning Emergency Planning meeting. The meeting was very well attended by watershed flood and emergency coordinators, and other provincial and federal partners. This biannual meeting covered great information about our flood warning system and emergency preparedness coordination, and included a presentation from Environment Canada on projections for hydro-climate variables of the Grand River basin. Great work from GRCA staff for hosting.
- Also on February 22, thank you to Councillor Mike Devine, one of our Region of Waterloo members for attending the federal funding announcement related to the Cambridge to Paris rail trail rehabilitation project being undertaken by the City of Cambridge.
- On February 6, staff presented the draft budget to Wellington-North council, and will
  continue presentations as requested.
- On February 2, S.Lawson joined MPP Mike Harris and others for a pre-budget consultation meeting for the provincial budget, presenting on behalf of the GRCA. Thank you Samantha for your presentation.
- Meetings with our participating municipalities regarding category 2 programs and services are ongoing, and staff have begun meeting with adjacent conservation authorities along with municipal staff in areas that share jurisdiction.
- Staff are working on a draft version of a Management Plan for the Niska land holdings, and will be posting on the GRCA website for public comment in the near future. More information will be prepared for the Board as needed.

  attributed to a major land sale, higher than anticipated Conservation Area
  revenues and tree sales, delayed projects costs, and savings in staffing costs
  due to vacancies.
- Some special and capital project delays include work on the Guelph Lake Nature Centre which should commence in 2023, and the Brant Workshop which is expected to be completed in 2023.
- J.Smith asked if deferred projects can be highlighted to the Board, and S.Radoja confirmed. Water control projects can be highlighted in capital reports, and Conservation Area projects can be included in financial forecasts.
- D.Miller noted that percentage of revenue from government grants, and highlighted that provincial and federal governments should be asked to maintain or increase funding levels.
- S.Radoja returned to the presentation, wrapping up with key highlights from reserve fund transfers.

WHEREAS it may be necessary for Grand River Conservation Authority (hereinafter called the "Authority") to borrow money, on an interim basis, to meet the Authority's financial obligations while awaiting payment of levies by participating municipalities designated as such under The Conservation Authorities Act, RSO 1990 (hereinafter called "Participating Municipalities");

#### THEREFORE BE IT RESOLVED:

THAT the Authority be authorized to borrow, on an interim basis, a sum or sums not exceeding in the aggregate One Million Dollars (\$1,000,000) from the Authority's bank at the said bank's minimum lending rate established from time to time, until the Authority has received payment of levies from Participating Municipalities;

AND THAT the Chair or Vice-Chair together with the Chief Administrative Officer or Secretary-Treasurer of the Authority be and they are hereby authorized to execute for and on behalf of the Authority, a promissory note or notes for the sum to be borrowed pursuant to this Resolution and to affix thereto the corporate seal of the Authority;

AND THAT the amount borrowed pursuant to this Resolution, together with interest thereon, be a charge upon the whole of the money received or to be received by the Authority by way of levies collected from Participating Municipalities when such moneys are received;

AND THAT the Chair or Vice-Chair or the Chief Administrative Officer or Secretary-Treasurer of the Authority be and is hereby authorized and directed to apply, in payment of the moneys borrowed pursuant to this Resolution together with interest thereon, all of the moneys received by the Authority by way of levies collected from Participating Municipalities.
